TOYS FOR TOTS PROGRAM
HOUSEHOLD ELIGIBILITY**

Calhoun County Sheriff's Office is the primary distributor for the Toys for Tots Program.

The majority of toys are distributed to families eligible through their local school/daycare.

All other eligible families (meet income guidelines as outlined below-Federal Poverty Rates of 150%) must be registered with the Calhoun County Sheriff's Office Toys for Tots Program prior to December 11, 2020.

HOUSEHOLD ELIGIBILITY FOR TOYS FOR TOTS PROGRAM:

1. Household must contain at least one child from age birth to 18 years old that is currently enrolled in school (if old enough to be enrolled) and reside in Calhoun County. (Provide proof of residency and Photo Identification)
2. Household must have legal guardianship and/or custody agreements of the child residing in the home.
3. Household must meet the following income eligibility guidelines. Household income is at or below 150% of the Federal Poverty Rates.
4. Household must register with the Calhoun County Sheriff's Office Toys For Tots Program for registration.
5. Household must receive the toys at the December Distribution and/or at a designated time at the Calhoun County Sheriff's Office.
6. Households receive up to 4 toys per child.
7. Households participating in any other local community, faith based organization, church or school program receiving toys should consider if the need for additional toys through the Toys for Tots Program is necessary. We need to make sure all children in the community with needs receive toys during the holiday season.
